However, it should be remembered that insufficient maintenance and improper handling can also result in a breakdown of your vehicle. You are cautioned, therefore, to observe carefully the periodic inspection and maintenance procedures stipulated in the attached coupons.

They will, if done regularly, ensure that your vehicle is always in excellent mechanical condition and that you do not lose the coverage of this warranty through neglect or failure to abide by its simple procedures.

WARRANTY POLICY

Nissan Motor Company Limited (hereinafter referred to as "Nissan") gives the following warranty on for your new vehicle:

1. The term of warranty shall expire twelve (12) months after the delivery to a customer, or after the vehicle shall have been driven over a distance of 12,000 miles or 20,000 kilometers whichever event shall first occur.
2. If at any time during the period covered by the warranty you find defects of material or workmanship in any parts of your vehicle, and if Nissan acknowledge this as a claim, a distributor or a dealer appointed by Nissan will replace or repair such defective parts without charge.
3. Nissan shall not be bound by this warranty even during the period it is in effect if any of the following occurs:
 - (1) Expenses: (a) of repairs done at shops other than those owned by a distributor or dealer designated by Nissan or those shops authorized by such distributors or dealers, and (b) accrued from breakdowns directly or indirectly attributable to such repairs.
 - (2) Any trouble caused by alteration or modification of the specifications or construction of the vehicle.
 - (3) For vehicles sold in chassis form, any trouble resulting from improper mounting (cab, body, etc.) to the chassis.
 - (4) Any trouble caused by the use of a part or parts other than Nissan genuine parts.
 - (5) Any trouble caused by failure to observe proper handling, operating, and maintenance instructions as stated in the specifications and Owner's Manual issued by Nissan. These



include breakdowns resulting from abuse, deliberate negligence, and insufficient maintenance.

(6) Any trouble caused by failure to follow periodical inspection of the vehicle as established by Nissan, and by failure to service the vehicle as based on the inspection results.

(7) Service and maintenance such as cleaning, lubricating, grease-job, replacement of parts and adjustments that are shown below:

Cleaning: Engine flushing, cleaning of fuel tank, etc.

Lubrication & Fluid: Changing or replenishing oil, lubricating, greasing, applying brake grease, filling battery electrolyte and antifreeze, etc.

Replacement of parts: Expendable parts with a service life of a certain established mileage.

Adjustments: Tuning engine, adjusting brake, clutch pedals, etc.

(8) Any breakdown resulting from driving the vehicle over terrain not intended for vehicular traffic.

4. No warranty shall be made for the following parts:

- (1) Spark plug
- (2) Electric bulb (except sealed beam)
- (3) Fuse
- (4) Air cleaner element
- (5) Oil filter element
- (6) Fan belt
- (7) Fuel strainer element
- (8) Other similar parts
